

**ORDINANCE NO. 15**  
**OF THE BOROUGH OF MILL VILLAGE**  
**ERIE COUNTY, PENNSYLVANIA**

AN ORDINANCE for the establishment of Maximum Weight Limits, relating to the use of the Streets of the Borough of Mill Village.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Mill Village, of the County of Erie and State of Pennsylvania, as follows:

**SECTION I**

It shall be unlawful for anyone, at any time, to go upon the Streets of the Borough of Mill Village with any truck, tractor, trailer, vehicles, machinery or other objects which have a gross weight, when loaded, of more than twenty thousand (20,000) pounds, or a gross weight, when unloaded of more than twenty thousand (20,000) pounds; provided, however, the said weight restrictions shall not apply to Streets located within the Borough of Mill Village which are maintained by the State of Pennsylvania of the United States of America.

**SECTION II**

The Borough of Mill Village shall install proper signs, and maintain the same, at the end of each Street affected hereby, for the purpose of giving proper notice of the weight restriction.

**SECTION III**

Any person who violates the provisions of this Ordinance, in addition to being subject to the legal and equitable rights of action of the Borough of Mill Village, shall upon summary conviction before a Magistrate be sentenced to pay a fine of Fifty (\$50.00) Dollars and costs of prosecution and in default of payment thereof shall undergo imprisonment for five (5) days.

**SECTION IV**

Should any part of this Ordinance be held invalid by a Court of Competent Jurisdiction, the remaining parts shall be severable and shall continue to be in force and effect.

ALL ORDINANCES or parts of Ordinances conflicting with provisions of this Ordinance are hereby repealed insofar as the same affect this Ordinance.
