

ORDINANCE NO. 18
MILL VILLAGE BOROUGH, ERIE COUNTY, PENNSYLVANIA
STREET NAMING AND STRUCTURE NUMBERING

An ordinance establishing the requirements for: uniform names for streets; a uniform structure numbering system; prescribing the method for obtaining structure numbers and street names; and authorizing the issuance of such numbers and names by the appropriate Borough official; under provisions granted by the Pennsylvania Borough Code, as amended.

SECTION I.

PURPOSE

- A. It is the opinion of the Mill Village Borough Council that it will promote the general welfare of Mill Village Borough to have a street name map delineating the official names, and the official spelling of such names, of all roads in Mill Village Borough.
- B. It is the opinion of the Borough Council that it will promote the general welfare of Mill Village Borough to have a uniform structure numbering system throughout Mill Village Borough.

SECTION II.

EXISTING STRUCTURES AND NUMBERING

- A. As of the adoption date of this Ordinance, all existing structures (houses, businesses, farm complexes, etc.) have assigned numbers and official street names in accordance with the Mill Village Borough Road Log, the Official Street Name Map of Mill Village Borough, and the Mill Village Borough Structure Location Reference Maps which are hereby adopted as part of this Ordinance.
- B. After the adoption date of this Ordinance, the owner of each existing structure or group of structures will receive an Informational Pamphlet and Official Notice, which will assign the number and official street name for each structure or group of structures. If certain owners of existing structures have not received such notice by the effective date of this Ordinance, said owners should contact the Mill Village Borough Secretary for number and official street name assignment.
- C. Upon receiving notice, the owner of each structure or group of structures shall secure a number which will be prominently posted on the structure or on the main building of a group of structures. The number may also be placed on a mailbox or other free standing device, in addition to placement on the structure, if the owner so desires. The assigned number of official street name shall be used on all correspondence thereafter.

SECTION III.

FUTURE STRUCTURES

- A. After the effective date of this Ordinance, any owner of property in Mill Village Borough who intends to place a new structure in Mill Village Borough, shall contact the Mill Village Borough Secretary for number and official street name

assignment as part of the normal building permit process. The owner of a new structure shall have one calendar month, after completion of the structure, to comply with Section II.C. of this Ordinance.

This Ordinance is hereby adopted, at the regular meeting of the Mill Village Borough Council, September 25 1986, and shall become effective seven (7) days after adoption.
